2. No advance payment will be made but payment is assured within 30 days from the date of satisfactory receipt of supply and submission of your bill, subject to the condition that all the required formalities are accomplished before submission of bill.
3. Items may be deleted / increased or decreased as per requirement, while placing the supply order.
4. The rates for respective quantities **to be delivered** at respective sites, should be quoted in enclosed format of Price Schedule on F.O.R at respective Delivery Points i.e. At **Near Minakshi Temple, Miscot Mohalla, i.e. extreme western part of Moti Lake, Motihari, East Champaran.**

5. The **supply** will have to be completed within **30 days** from the date of receipt of the respective supply order. In the case of failure to execute the supply, within the period stipulated, in the respective supply order, **penalty will be charged @ 0.05% per day.**
6. **Mandatory documents to be attached are:**
 - i. **REGISTRATION CERTIFICATE**
 - ii. **COPY OF GST REGISTRATION/NUMBER**
 - iii. **INCOME TAX RETURN OF 2015-16 OR LATEST**
 - iv. **COPY OF PAN CARD**

The above document must be enclosed with the quotation, failing which the quotation may not be considered.

7. Tenderers are advised to inspect the site and its surroundings and satisfy themselves before submitting their tender as to the nature of the ground and sub-soil, the form and nature of the site, the means of access of the site, and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent upon any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools and paints, facilities for workers and all other services required for executing type of work and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specification of the work to be done and all the stores, tools and plant, etc., to be arranged by him by the Government and local conditions and other factors having a bearing on the execution of the work.

The Institute will not be held responsible for payment of any compensation to the labourers engaged by him for any sort of things.
12. The bids will be evaluated based on the rates quoted by bidders. The lowest-quoting bid amongst the Technically responsive Bidders would be considered for the award of Contract. However, it is not mandatory to select the lowest quotation.

13. **VALIDITY OF BID MUST BE FOR AT LEAST 90 DAYS.**
14. **The rate must be quoted for hiring of charges including POL, Labour Charges, etc. No extra charges will be borne by the Institute.**
15. **Performance Security @ 5% of the anticipated overall drawal will be obtained at the time of award of Contract, from the successful contract awardee(s), in the shape of Demand Draft/Bank Guarantee drawn in favour of “ICAR Unit: ICAR-RCER, Patna”, which will be refunded after satisfactory completion of three months.**
16. Tendering firm will be required to indicate their valid Income Tax /PAN No., Bank details for releasing of payment through RTGS etc.
17. Conditional offers are liable to be rejected summarily.
18. The Director, ICAR Research Complex for Eastern Region, Patna reserves all rights to accept or reject any of the quotations without assigning any reasons thereof.
19. **The tender document should be submitted intact with tenderer’s signature and seal on every page and any pages should not be detached.** Failing this, the firm would be disqualified on technical grounds.
